Exhibiting at the 25th Color and Imaging Conference provides an opportunity for companies to engage with individuals from academia, private companies, government agencies, and public institutions working in color imaging, display systems, color perception, color workflow, and color measurement during the conference's technical program: September 11-15, 2017. To allow for the greatest exposure, the exhibit will be held in proximity to registration, the coffee breaks, and the Interactive (poster) Papers.

IS&T and all organizations and individuals who are employed by or associated with it, in connection with this Exhibit Session, will not assume responsibility and shall be held harmless by all Exhibitors for damage or loss resulting from fire, theft, or any other cause whatsoever, including accident or injury to Exhibitors, their employees and agents, the public, or others. The Exhibitor agrees to pay promptly for any and all damages to the exhibition building or its equipment incurred through carelessness or otherwise, of Exhibitor or its employees or agents.

PAYMENT SCHEDULE: Please note, space is limited, and until approved by IS&T, a signed contract with payment is not a guarantee that you will be able to exhibit. Space must be reserved by August 1, 2017. Full payment must be received by August 15, 2017.

No space will be reserved or assigned unless both the fee and signed contract are received at IS&T's Headquarters at 7003 Kilworth Lane, Springfield, VA 22151 USA. Fees can be made by credit card, check, or bank transfer (contact IS&T for details).

LOCATION: IS&T reserves the right to determine placement of exhibitors. If you do not wish to be placed near a competitor, note their name(s) under "special requests" on the front of this form.

TRANSPORTATION/SETUP: All transportation and other costs related to exhibit/demonstration setup not explicitly offered by IS&T are to be paid by the Exhibitor.

LOSSES: IS&T will not take responsibility for damage to the Exhibitor's property or lost shipments either coming in or going out, nor for moving costs. Damage to inadequately packed property is Exhibitor's own responsibility.

SECURITY: IS&T cannot be held responsible for loss or damage to any Exhibitor's property. Exhibitors are advised to insure against these risks. There will be no on-site security.

MUSIC LICENSING: No copyrighted music may be played in the exhibit/demonstration area in any fashion (including but not limited to background music on video or audio tape presentations) without appropriate licensing. The Exhibitor is solely responsible for obtaining these licenses for music originating in the Exhibitor's booth/ display area. The Exhibitor is also responsible all costs that

may arise from failure to comply with these licensing requirements.

CANCELLATION: Cancellation of this contract must be made in writing and sent to IS&T's Headquarters at 7003 Kilworth Lane, Springfield, VA 22151 USA. Cancellations or space reductions will be subject to charges according to the following schedule:

- From date of signing until midnight August 11, 2017 a 50% refund will be given, minus a \$75 processing fee.
- No refunds will be given after 12:00 am (EST) August 11, 2017.
- All requests for cancellation must be received in writing.

TERMINATION OF DEMONSTRATION: In the event that the premises in which the exhibit is to be conducted become, at the sole discretion of IS&T, unfit for occupancy, or in the case that the holding of the exhibit or the performance of IS&T under the exhibit reservation agreement are substantially or materially interfered with by virtue of cause or causes not reasonably within the control of IS&T, the agreement or the exhibit (or any part thereof) may be terminated by IS&T. IS&T shall not be responsible for delays, damage, loss, increased costs, or other unfavorable conditions arising by virtue of cause or causes not reasonably within the control of IS&T. If IS&T terminates this agreement and/or the exhibit (or any part thereof), then IS&T shall not be liable to the exhibitor other than for a prorated refund of such exhibitor's space reservation payment as determined on the basis of the number of exhibit days remaining. The phrase "cause or causes not reasonably within the control of IS&T" shall include, but not be limited to: fire, casualty, flood, epidemic, earthquake or inclement weather, explosion or accident; blockage or embargo; governmental restraints; restraints or orders of civil defense or military authorities; acts of public enemy, riot, or civil disturbance; strike, lockout, boycott, or other labor disturbance; inability to secure sufficient labor, technical, or other personnel; failure, impairment, or lack of adequate transportation facilities; inability to obtain, or condemnation, requisition, or commandeering of necessary supplies or equipment; local, state, or Federal law, ordinances, rule, order, decree and/or regulation, whether legislative, executive, or judicial, and whether constitutional or unconstitutional; or Acts of God.
